T Organizational/Community/International Services

Programs that provide any of a broad spectrum of services that benefit entire communities or which offer services that are statewide, regional, national or international in scope. Included are opportunities for individuals or groups to enjoy the artistic and cultural life of the community, participate in community improvement or service projects, engage in philanthropic endeavors, have a voice in the political process, obtain or offer assistance in times of disaster, have access to information services, and/or benefit from the availability of a variety of services for residents, community agencies, organizations, businesses and industries, and other individuals/groups.

TH Disaster Services

Public and private programs that provide emergency planning, preparedness, mitigation, response, relief and/or recovery services prior to, during and after a major fire, flood, hurricane, earthquake, tornado, tsunami, volcanic eruption, landslide, mudslide, snowstorm, drought, famine, explosion or nuclear accident, the outbreak of civil unrest, or other large-scale emergency of natural or human origin that disrupts the normal functioning of a community; or a localized incident such as a house fire which has made residents homeless. There are four recognized phases of disaster work: preparedness, mitigation, response and recovery. Many community agencies add disaster relief as a phase during response and early recovery.

Natural Disaster Services

TH-1500 Disaster Management Organizations

Public and private organizations that are responsible for the organized analysis, planning, decision making, assignment and coordination of available resources involved in the mitigation of, preparedness for, response to, and/or relief/recovery from a major disaster or large-scale emergency that disrupts the normal functioning of a community. These organizations have a formal role in developing overall emergency policy within their jurisdictions; establish coordination with other agencies active in disaster situations; develop action plans for emergency response; coordinate facilities, services, personnel, equipment and materials that are required before, during and immediately following an incident; and/or are involved in disaster relief and recovery activities.

TH-1500.1300 Campus Emergency Response Teams

Teams established on college and university campuses whose members (typically faculty and staff from different departments and divisions as well as students) have received training that prepares them to serve as first responders following a major campus emergency. Responsibilities may include light search and rescue and extrication of individuals who may be trapped; first aid and triage services for people who are injured; fire suppression; and support for other emergency operations.

City government offices that have primary responsibility for the coordination of emergency management activities including planning, preparedness, response, recovery and mitigation; and which serve as the central point of contact for receiving reports of incidents that occur within their jurisdiction and for disseminating emergency-related information.

TH-1500.1600 County Offices of Emergency Services

County government offices that have primary responsibility for the coordination of emergency management activities including planning, preparedness, response, recovery and mitigation; and which serve as the central point of contact for receiving reports of incidents that occur within their jurisdiction and for disseminating emergency-related information.

TH-1500.1700 Disaster Relief/Recovery Organizations

Organizations that have a formal role in coordinating the provision of disaster relief and/or recovery services following a major disaster or large-scale emergency that disrupts the normal functioning of a community. Included are coalitions of community-based organizations in a defined geographic area whose members are prepared to act in concert to respond to the emergency needs of the community during the relief and recovery phases of a disaster and non-affiliated organizations with a designated role. Some collaboratives are local VOADs (known in some places as COADs), that are organized through state-level VOAD/COAD chapters which are affiliates of the national organization, National Voluntary Organizations Active in Disaster (NVOAD), a formal coalition of national voluntary organizations with a common interest in providing disaster relief. Other coalitions are "interfaiths" which gather financial and other resources from the faith community and distribute them to people in need, generally after American Red Cross and other immediate relief organizations have completed their work. NOTE: "Disaster Relief" is a category of services utilized by community agencies involved in disaster work. Government organizations do not recognize disaster relief as a formal part of the disaster cycle. Most of the services classified as disaster relief are considered by government to be part of disaster recovery and a few (e.g., disaster welfare inquiries) are categorized as disaster response.

Designated departments and agencies have primary or support responsibilities based on their authorities, resources and capabilities in a particular functional area.

Functional components include public affairs, community relations, congressional affairs, international affairs, state and local coordination and tribal affairs. Activities include activation and operation, in coordination with state authorities, of the emergency alert system (EAS) which enables authorities to deliver emergency messages and instructions in audio format; providing mobile telecommunications, operational support, life support and power generation assets for the on-site management of all-hazard activities; and working with local broadcasters to set up the Recovery Radio Network which enables stations to reach a series of recorded messages that provide the latest up-to-the minute reports on the federal government's response and recovery operations by dialing a toll free number. Stations may choose to record these briefs for use in their newscasts.

Offices of the Federal Emergency Management Agency (FEMA), the central agency within the federal government that is responsible for federal efforts to reduce the loss of life through a comprehensive, all-hazards emergency management program of emergency planning, preparedness, mitigation, response and recovery. Working closely with state and local governments, FEMA funds emergency programs, offers technical guidance and training and deploys federal resources in times of disaster. FEMA's programs include response to and recovery from major natural disasters and human-caused emergencies, emergency management planning, flood-plain management, hazardous materials planning, dam safety and multihazard response planning. Other activities include off-site planning for emergencies at commercial nuclear power plants and the army's chemical stockpile sites, plans to ensure the continuity of the federal government during national security emergencies and federal response to the consequences of major terrorist incidents.

resources occurs, state disaster/emergency officials advise the FEMA Regional Director that the Governor is requesting or intends to request a declaration by the President. The FEMA Regional Director evaluates the damage and requirements for federal assistance and makes a recommendation to the Director or FEMA who, in turn, recommends a course of action to the President. If the President declares a major disaster or emergency, an appropriate FEMA (or other federal) official is appointed as the Federal Coordinating Officer (FCO) to work directly with the State Coordinating Officer to mobilize and coordinate federal resources. Emergency support teams, composed of disaster assistance specialists from federal agencies, assist the FCO in carrying out his or her responsibilities.

Protected sites established by federal, state, county or city authorities or other local jurisdictions, often in cooperation with private entities, that are used for the centralized direction and coordination of emergency services during a major disaster. Government disaster operations centers maintain vital facilities, services and communications and take whatever actions are necessary to minimize casualties and loss or damage to property during and after the incident and to facilitate the community's ability to recover.

Landslides are associated with instability of slopes which results in the downward and outward movement of rocks, soil, artificial fill or a combination of these materials. Mudslides (i.e., mudflows) are caused by an accumulation of water on or under the ground, often in areas that have lost ground and brush cover as may occur in the aftermath a fire.

Radiological accidents can occur anywhere that radioactive materials are used, stored or transported, and involve the release of potentially dangerous materials into the environment, usually in the form of a cloud or "plume" that can affect the health and safety of anyone in its path. Protection in a nuclear emergency comes from

distance (the more distance from the radiation the better), shielding (protection using heavy materials to absorb radiation) and time (radiation loses intensity rapidly).

In the case of terrorism involving chemical or biological agents, information is also provided about the etiology, symptoms, preventive measures, screening/diagnostic procedures and/or treatment or management of illnesses or other health conditions victims may acquire as a result of an attack.

The vortex, up to several hundred yards wide, is visible to the observer as a whirlpool-like column of winds rotating about a hollow cavity or funnel.

Tsunami wave activity is virtually imperceptible in the open ocean but tremendously destructive when it reaches shore, potentially stripping beaches of sand, undermining trees and other coastal vegetation and moving inland hundreds of feet, crushing boats, homes and other coastal structures in its wake. At some locations, the advancing turbulent front may be the most destructive part of the wave; at others the greatest damage may be caused by the outflow of water back to sea.

A volunteer program established by the National Weather Service to train, certify and coordinate the activities of storm spotters, i.e., individuals who observe the visual cues associated with the development and progression of hazardous weather events and provide real-time descriptions of tornadoes, high winds, hail and significant cloud formations to the local weather service office and emergency managers in a timely manner. The program is administered through local weather forecast offices, each with a warning coordination meteorologist. Training is conducted at these local offices and focuses on the basics of thunderstorm development, the fundamentals of storm structure, identifying potential severe weather features, information to report, how to report information and basic severe weather safety. The reports of storm spotters become part of the weather warning decision making process and when combined with radar data and other information, are used by National Weather Service forecasters to decide whether to issue a new warning, cancel an existing warning, continue a warning, and/or issue a warning for the next county. Spotter reports also help local public safety officials make decisions to protect lives and property such as when to sound sirens, activate safety plans and take other necessary steps when severe weather is approaching.

TH-1700.1930 Emergency Management Exercises

Programs that are responsible for organizing exercises at the local, state or national level to test, evaluate and continually improve the emergency management system and the emergency operations plan. Exercises are simulated emergencies in which members of various agencies perform the tasks that would be expected of them in a real emergency. Included are drills which develop, test, and monitor specialized emergency skills in a single or limited emergency response procedure (e.g., communication) often within a single agency or department; tabletop exercises in which key staff or other emergency management personnel are gathered together informally and without time constraints, usually in a conference room setting, to discuss various simulated emergency situations, associated problems and resolutions; functional exercises which use a scenario to test the capability of individual or multiple emergency functions and give the players (the decisionmakers) a fully simulated experience of being in a major emergency event without movement of personnel and equipment; and full scale exercises which involve the mobilization of personnel, equipment and resources, their actual movement, and testing of the coordination and response capability.

Emergency management agencies, health departments and other entities that conduct multi-hazard planning for their communities that will enable them to mitigate, prepare for, respond to or recover from natural disasters, public health crises, terrorist incidents or other emergencies that occur within or have an impact on their area. Emergency planning addresses citizen awareness and self-sufficiency, responder capabilities, interagency cooperation in emergency operations and the roles, responsibilities and activities of public and private organizations and their staffs in all phases of the disaster.

TH-1700.2000 Emergency Preparedness and Response Training

TH-1700.2000-100 Business Continuity Consultation Programs

Programs that help businesses and other organizations make an assessment of their vulnerabilities to a wide variety of threats (ranging from structural fires, localized flooding, telecommunications/data systems failures and other local events to widespread occurrences such as earthquakes or hurricanes that disrupt the functioning of an entire community); and develop a contingency plan for responding to an emergency if one should occur. A business continuity program includes emergency preparedness and mitigation activities such as structural alternations and changes in business operations and a plan to address the steps to be taken before, during and after an emergency to prevent or minimize interruptions in business operations and assure long-term recovery. The objective of business continuity planning is to reduce the level of risk to the business and control

the impact on personnel, customers, suppliers and others associated with the organization.

TH-1700.2000-150 Community Disaster Education

Programs, activities and materials provided by organizations like the American Red Cross and the Federal Emergency Management Agency (FEMA) that educate the public and help individuals and families prepare in advance for a major disaster or large-scale emergency that disrupts the normal functioning of a community. Community disaster education provides general planning and safety information for a variety of risks including fires, floods, earthquakes, hurricanes, tornadoes, heat waves and winter storms; and delineates concrete steps that people can take to inform themselves of the disasters most likely to occur in their area, develop and practice a disaster plan, purchase emergency supplies, secure their property and be ready to work as a team with family members and neighbors when an incident occurs.

Programs that provide training for community based organizations which helps them prepare for assuming a responsible role in a major disaster or large-scale emergency that disrupts the normal functioning of a community. Included are programs that provide training which helps organizations develop and test internal emergency plans for minimizing the loss of life and property during and immediately following an incident as well as those that focus on helping information and referral programs and other community-based organizations define their mission in a disaster situation and develop the relationships they need to become a formal part of the disaster planning, relief and recovery efforts in their community.

Programs that maintain information about people who may require special assistance in the event of a disaster or crisis that will tell emergency responders or volunteers where they are located and the type of care and support they need. Registration is voluntary, but is strongly encouraged for people who have special medical needs (e.g., oxygen or life support systems that are dependent on electrical power) or have physical disabilities that complicate their ability to evacuate or use shelter facilities without assistance. Some programs encourage everyone to register with the expectation that detailed information can facilitate critical help for the individual and family members in the event of an emergency.

Some disaster kits may have special supplies for cold weather.

TH-1700.6400-650 Potassium Iodide Distribution Programs

Radioactive iodine, one of the contaminants that can be released in a nuclear accident or similar event, can increase the risk of thyroid cancer. The pills, which block exposure to the contaminant, are generally safe but can cause health problems for individuals with existing thyroid conditions or allergies to iodine or shellfish.

Programs that provide special weather alert radios that people can use during national emergencies, tornadoes, thunderstorms, hurricanes and other disasters of human or natural origin to access emergency warning information and suggested protective measures 24-hours per day.

Mitigation includes any activities that prevent or reduce the chance of an emergency occurring or lessen the damaging effects of unavoidable emergencies.

TH-1800.1600 Disaster Control Programs

Programs that seek to prevent or control the nature, severity or frequency of specific types of disasters by modifying conditions which are known to have a role in their occurrence.

Programs that seek to control the size and frequency of avalanches or to direct the path of an avalanche by establishing avalanche hazard zones which map the level of avalanche risk in specific areas; using explosives, test skiing or other equipment or techniques to set off an avalanche pre-emptively and stabilize an avalanche area; installing diversion and anchoring structures to prevent or control the course of snow glides; or taking other measures to prevent avalanches or protect individuals, property and natural resources from their destructive effects.

TH-1800.1700 Disaster Mitigation Relocation Programs

A program administered by state governments and funded by the Federal Emergency Management Agency (FEMA) which permanently removes inhabited structures from high risk areas in order to restore flood plains and reduce the loss of life and property when flooding occurs. This voluntary program allows individuals covered by flood insurance under the National Flood Insurance Program (NFIP) to sell repeatedly or substantially damaged structures in flood risk areas and relocate to sites outside those areas. The community in which the property is located must agree to accept title to the property and restrict its use to open space recreation, even if title is subsequently transferred by the community.

Work often begins before the fire is fully contained and includes measures to stabilize soil, control water flow, minimize sediment and debris runoff, protect the ecosystem and watersheds and mitigate significant threats to health, safety, life, property and downstream values such as municipal water supply reservoirs that may be at risk. Burned Area Emergency Response (BAER) team members generally come from a number of government agencies and may include hydrologists, wildlife biologists, archaeologists, soils scientists, landscape architects, geologists, ecologists, engineers, foresters, botanists, and GIS specialists.

TH-1800.6600-800 Structural Retrofitting Services

Programs that make permanent changes to homes, apartment buildings and other structures which enable them to withstand the shaking that occurs in an earthquake, high winds that may accompany severe weather, tidal surges associated with a hurricane or tsunami, fire or other destructive forces. Retrofitting may include bolting the frame of a home or other building to its foundation, adding steel reinforcements to unreinforced concrete walls, bracing chimneys, anchoring fuel storage tanks, utilizing fire-resistant building materials and other similar improvements that are expected to make the structure more disaster resistant.

TH-2100 Disaster Warnings

Disaster warnings may include safety instructions for people who are likely to be affected by the event, may communicate information about measures, such as curfews, that the authorities have taken to minimize the effects of the incident, and may provide crucial information about the status of the physical environment (e.g., roads and bridges that are impassable) following the event.

An earthquake is the sudden motion or trembling of the ground produced by abrupt displacement of rock masses, usually within the upper 10 to 20 miles of the earth.

Radiological accidents can occur anywhere that radioactive materials are used, stored or transported, and involve the release of potentially dangerous materials into the environment, usually in the form of a cloud or "plume" that can affect the health and safety of anyone in its path. Protection in a nuclear emergency comes from distance (the more distance from the radiation the better), shielding (protection using heavy materials to absorb radiation) and time (radiation loses intensity rapidly). Radiological emergency

warnings may include steps, including evacuation or "shelter in place" instructions, that people in the affected area can take to preserve their safety.

In the case of terrorism involving chemical or biological agents, warnings identify the type of health hazard involved; the area likely to be affected (if known); steps that people can take to protect themselves; evacuation routes (if necessary); shelter locations (if relevant); the etiology, symptoms, preventive measures, screening/diagnostic procedures and/or treatment or management of illnesses or other health conditions victims may acquire as a result of an attack; and the types and location of appropriate medical facilities.

TH-2100.8300-150 Chemical Terrorist Attack Warnings

Programs that issue warnings regarding potential terrorist incidents involving the intentional release of chemical agents with the objective of doing harm. Included may be chemical weapons developed for military use; toxic industrial and commercial chemicals that are produced, transported and stored in the making of petroleum, textiles, plastics, fertilizers, paper, foods, pesticides, household cleaners and other products; or chemical toxins of biological origin such as ricin. Warnings identify the type of health hazard involved; the area likely to be affected (if known); steps that people can take to protect themselves, e.g., sheltering in place; the etiology, symptoms, preventive measures, screening/diagnostic procedures and/ or treatment or management of illnesses or other health conditions victims may acquire as a result of an attack; and the types and location of appropriate medical facilities.

TH-2100.8500 Tsunami Advisories

Programs that activate warning systems (sirens or other mechanisms) and/or issue bulletins to warn the public of ocean-based earthquakes, volcanic eruptions or other events which are likely to produce tsunamis. Tsunami watches indicate that a tsunami is possible but not confirmed. Tsunami warnings confirm the approach of a tsunami and may include safety instructions for people who are in immediate peril. A tsunami is a series of ocean waves generated by the sudden displacement of large volumes of water by thrust-type submarine earthquakes, submarine volcanic eruptions, meteor impact, or coastal landslides. Tsunami wave activity is virtually imperceptible in the open ocean but tremendously destructive when it reaches shore, potentially stripping beaches of sand, undermining trees and other coastal vegetation and moving inland hundreds of feet, crushing boats, homes and other coastal structures in its wake. At some locations, the advancing turbulent front may be the most destructive part of the wave; at others the greatest damage may be caused by the outflow of water back to sea.

When temperatures and the heat/humidity index are expected to be 100 degrees Fahrenheit (or higher, a heat advisory is issued. A heat warning is issued for temperatures and/or heat indices of 110 degrees Fahrenheit or higher. The exact combination of indices may vary between jurisdictions and may include factors such as dew point, cloud cover, humidity, wind speed and direction, and the duration of the hot spell. Extreme heat can be very dangerous when combined with high humidity or drought conditions.

Tornado advisories may also include safety instructions for people who are in immediate peril.

TH-2300.1300 Disaster Declarations Information

Programs that provide information about the disaster declaration status of states (and localities within states) that have experienced a specific situation such as a fire, flood, storm, earthquake, epidemic, drought, sudden and severe energy shortage or other similar condition that is beyond the ability of local and/or state authorities to manage. The process to request state and/or federal assistance after a disaster or emergency is initiated when the local governing body or the Governor submits a formal request to the appropriate state or federal office. Program and financial assistance vary depending on the type of declaration or proclamation, whether the situation constitutes an emergency or a disaster, and the type of assistance required. A declaration by the President of a federal major disaster or emergency is required to initiate the flow of federal resources.

TH-2300.1400 Emergency Communications

Programs that provide services, often through one or more intermediaries, which enable two or more parties to communicate in emergency situations where normal means of communication are unavailable. Included are individuals (such as amateur radio or CB operators) and organizations (such as Amateur Radio Emergency Service) that provide alternative communications channels following a major disaster or large-scale emergency that disrupts the normal functioning of a community.

Services may include police units that are trained in handling large crowds and riot situations; SWAT teams that specialize in high-risk situations requiring special tactical skills; law enforcement dive teams that are used to recover evidence, drowning victims or lost vessels; patrol dogs that help to apprehend offenders, detect intruders, find lost children or handle other police work; and canine units that are trained to detect cadavers, explosives or narcotics.

The assignment of personnel and equipment are dependent upon availability of the releasing mutual aid partner, and have an agreed timeframe for the release of these resources. The host recipients provide or assist with accommodations for the duration of the team stay. Members must have the experience and financial capabilities to support equipment and personnel and maintain operations for an indefinite period of time. Essential customers such as hospitals, power plants, water plants, wastewater treatment plants, wastewater lift stations, law enforcement and fire stations generally receive priority.

Programs that provide immediate, short-term assistance for individuals who have been injured during a major disaster or large-scale emergency that disrupts the normal functioning of a community. Services may be provided at temporary facilities that have been established in or near the affected area or at sites where injured individuals have assembled and include on-site triage, rapid emergency care of life threatening conditions, sequential triage and timely evacuation of patients, when necessary.

In disaster situations in which regional and area hospitals are overwhelmed or unusable, the CCP can function as a receiving center for casualties from the injury site and for hospital patients needing continuing care. The CCP, in this instance, is an evacuation conduit. In a disaster with a large number of casualties, many of which do not need hospital care, the CCP may triage patients and control access to functioning hospitals and emergency rooms. In disaster situations in which normal hospital operations are functioning and not overwhelmed, CCPs may function as minor treatment facilities for people who need first aid and/or patient holding facilities for the selective evacuation of hospital patients. CCP sites may be colocated at certain existing hospitals.

Federally designated teams made up of volunteer physicians, nurses, nurse practitioners, physician's assistants, pharmacists and other health professionals that are pre-organized, trained and equipped to provide austere medical care in area and regional hospitals, at casualty collection points, in field hospitals or at sites where ill or injured individuals have assembled. Some DMAT teams have specific training and skills in the acute management of burn trauma patients or individuals with crush injuries.

emergencies can result in disruptions to critical infrastructure systems (electricity, power, water) which can cause life-threatening situations for individuals who rely on electricity-dependent durable medical equipment for daily living and critical life support functions. Examples of needed equipment include wheelchairs (manual and electric), hospital beds, ventilators, oxygen and oxygen concentrators (and accessories), C-PAP continuous airway pressure devices, powered suction pumps, nebulizers, glucose monitors, traction equipment, canes, crutches, walkers, pressure mattresses, lifts, infusion and feeding pumps, as well as types of medical support needed for people injured during an incident.

Programs that conduct inspections of public works such as dams, levees, bridges and overpasses to ensure their structural safety before or during a flood or after an earthquake, tornado or other destructive event.

Some disaster dogs are trained to work in water and are called in to help locate people who have drowned. Others, called cadaver dogs, are trained for search and recovery operations for deceased victims. Search dog teams provide support for search and rescue operations in a variety of environments.

The objective of disaster relief is to help individuals sustain their lives during the immediate aftermath of the event. Government organizations do not recognize disaster relief as a formal part of the disaster cycle. Most of the services classified as disaster relief are considered by government to be part of disaster recovery and a few (e.g., disaster welfare inquiries) are categorized as disaster response.

Programs that gather and disseminate to the public, government agencies, the media and other organizations information regarding the status of critical

community services following a major disaster or large-scale emergency that disrupts the normal functioning of a community.

Displaced individuals on probation or parole may be given a number to call or asked to report to the nearest parole or probation office in their current location for intake and supervision instructions.

Programs that gather information about the service needs of communities during times of disaster and report gaps in services for affected populations, duplication of effort, inefficient use or resources, bottlenecks or other impediments to people who are in a position to resolve these types of issues. Included are organizations that establish hotlines that community residents, first responders, relief volunteers and others can use to report problems in response, relief and/or recovery efforts as well as those that have people on the ground as observers or take other steps to assess and rectify problems with assistance efforts.

Programs that arrange for shelter and/or a warm place for people to stay when dangerously cold weather is expected; and/or provide emergency shelter for people who have no place to stay as a result of a large-scale fire, flood, earthquake, tornado, hurricane, or a localized incident such as a house fire, toxic spill emergency or other environmental hazard that disrupts the normal functioning of a community.

Special needs shelter clients include people with stable medical conditions that require periodic observation, assessment and maintenance (e.g., glucose readings, vital signs, ostomy care); people requiring periodic wound care; people with limitations which require assistance with activities of daily living; people who require assistance with their medication; people who require oxygen or are medically dependent on uninterrupted electricity for other therapies such as nebulizers or feeding tubes; and people who require full-time care and are accompanied by a full-time caregiver for the duration of their shelter stay.

Disaster Unemployment Assistance is available to individuals for weeks of unemployment beginning with the first week following the date the major disaster began and for up to 26 weeks after the major disaster was declared by the President, as long as their unemployment continues to be a result of the incident. The maximum weekly benefit amount is determined under the provisions of the state law for unemployment insurance in the state where the disaster occurred. The program is administered by states as agents of the federal government.

TH-2600.1880 Extreme Cold Warming Centers

Programs that provide daytime or evening access to heated facilities during times of extreme cold for people who are temporarily at risk for exposure due to a power failure, fuel shortage, road closure, homelessness or other situations which make them vulnerable.

TH-2600.1900 Extreme Heat Cooling Programs

Programs that provide access to air conditioned facilities, extend the hours during which public swimming pools and local spray grounds are open, activate street shower sites or take other steps to protect the public's health during dangerously hot weather. Some communities operate hotlines that residents can call if they see people on the street who are in distress due to the heat so that vans can be dispatched to take victims to cooling centers or other places of shelter. At greatest risk during heat emergencies are older adults, young children, individuals with compromised immune systems and people who take certain types of medication. Existing health conditions such as chronic illness, hypertension, circulatory problems, and obesity can also heighten an individual's vulnerability.

The major concern for anyone exposed to unsanitary conditions is that they be up to date with tetanus-containing vaccine, because if they are injured (as is common in disaster settings) the injury is likely to be contaminated. In addition, any displaced person living in a crowded group setting should receive influenza, varicella, and MMR vaccines. Immunocompromised persons in these settings should not receive the live virus vaccines MMR and varicella. Public health officials are generally available to work with evacuation center staff regarding administration of other recommended vaccines.

Desirable facilities are those with tight sealing windows, doors and public access and a ventilation system that is able to significantly reduce or eliminate intake of outdoor air. Depending on wind patterns, even cities far away from a fire may be affected. Particulate matter exposure is the principal public health threat from short-term exposures to wildfire smoke. The effects of smoke range from eye and respiratory tract irritation to more serious disorders, including reduced lung function, bronchitis, exacerbation of asthma and heart failure, and premature death.

TH-2900 Disaster Recovery Services

Programs that provide longer-term assistance for people who have suffered injuries or incurred losses due to a major disaster or large-scale emergency that disrupts the normal functioning of a community with the objective of facilitating the return of the community to its pre-disaster condition and/or rebuilding the community in a way that makes it less vulnerable in the future.

TH-2900.1650 Disaster Claims Information

Programs that provide information for individuals, businesses, nonprofit organizations and/or communities regarding compensation criteria and filing procedures for corporate or federal, state or local reimbursement of disaster-related expenditures and/or compensation for disaster-related bodily injury, damage to natural resources, loss of income/earning capacity, net loss of profits or earnings from a business, damage to facilities and equipment or property loss.

TH-2900.1700 Disaster Donations Coordination

Organizations that assume responsibility in the aftermath of a major disaster or large-scale emergency for soliciting and/or collecting donations from the general public and distributing those items to people who have suffered a loss and are currently in need. Donations may include critical services, money, groceries, drinking water, blankets, personal comfort kits, disposable diapers, clothing, household goods, medical supplies, cleaning supplies, hand tools, plastic sheeting, tar paper, building materials and other relief supplies.

TH-2900.1700-160 Disaster Donations Hotlines

Programs that operate special hotlines during the aftermath of a major disaster or large-scale emergency that people who wish to make donations can contact for information about the types of goods and services that are needed and/or the site(s) where donations are being collected.

TH-2900.1700-180 Disaster Donations Matching Services

Programs that connect individuals who wish to make a donation during the aftermath of a major disaster or large-scale emergency with individuals affected by the disaster who need the assistance and/or which manage in-kind donations provided by companies in times of disaster for the Red Cross, other charitable organizations, government entities or community agencies active in disaster relief and/or recovery.

TH-2900.1700-200 Disaster Donations Staging Areas

Designated sites, usually strategically located outside but in close proximity to an area affected by a major disaster or large-scale emergency, where donated materials are collected prior to transport and distribution.

TH-2900.1700-260 Disaster Related Goods Donations Management

Organizations that assume responsibility in the aftermath of a major disaster or large-scale emergency for collecting donated goods such as food, drinking water, blankets, medical supplies and cleaning supplies from the general public, sorting the items, confirming what need exist, and coordinating the distribution of those items to people who have suffered a loss.

TH-2900.1700-300 Disaster Related Monetary Fund Management

Organizations that initiate fundraising drives in the wake of a major disaster or large-scale emergency, collect monetary contributions from the general public, and use the money to support their own relief efforts or distribute the funds to organizations that have a designated role in times of disaster or directly to people who have suffered a loss.

TH-2900.1750 Disaster Loans

Programs that provide low-interest loans for people whose homes, personal property or businesses have been destroyed or have suffered disaster-related damage. Some programs require that the community be declared a disaster area by the President or the Governor before making the loans available.

TH-2900.1750-100 Business Disaster Loans

Programs that provide low-interest loans for people whose businesses have been destroyed or have suffered disaster-related damage. Some programs require that the community be declared a disaster area by the President or the Governor before making the loans available.

TH-2900.1750-650 Personal Disaster Loans

Programs that provide low-interest personal loans for people whose homes and/or personal property have been destroyed or have suffered disaster-related damage. Some programs require that the community be declared a disaster area by the President or the Governor before making the loans available.

TH-2900.1780 Disaster Related Case Management

Programs that provide a single point of contact for disaster assistance applicants who need a wide variety of services that may be provided by many different organizations. The objective is to create a coordinated system that enables an individual or family who has survived a disaster to provide information about their situation to one organization that serves as their advocate and helps them organize and access disaster related resources and implement a recovery plan that will help them achieve pre-disaster levels of functioning and equilibrium. Disaster-related case managers assess the individual's needs, coordinate the delivery of needed services, ensure that services are obtained in accordance with the recovery plan, and follow up and monitor progress to ensure that services are having a beneficial impact on the problem. The service is particularly critical in situations where large-scale deaths and injuries have occurred.

TH-2900.1785 Disaster Related Cash Grants

Programs that provide cash grants to businesses, individuals and families who have been affected by a major disaster or large-scale emergency including a public health crisis like a pandemic that disrupts the normal functioning of a community. Monies can generally be used to pay for temporary housing, housing repair or replacement, permanent housing construction, moving and storage, personal property replacement, medical and dental services, funeral and burial services, transportation assistance and other expenses not covered by insurance or other programs. Included are the FEMA Individuals and Households Program (a program jointly funded by the federal government and the state and administered by the state), stimulus packages approved by Congress and signed by the President, state supplemental programs, and disaster related cash grant programs offered by local government and private sector organizations.

Disaster victims meet with caseworkers who assess their needs and supply clothing, rent assistance, beds and bedding, necessary furniture, cooking and eating utensils, occupational supplies, prescription medication, small appliances and other necessities.

Programs that provide financial assistance, volunteer labor, equipment and supplies or other forms of support to help clear away rubble and clean up the community following a major disaster or large-scale emergency that has wreaked havoc on the community.

TH-2900.6400-170 Disaster Related Debris Removal

TH-2900.6400-600 Post Disaster Cleanup Crews

Programs that mobilize volunteers in areas which have been devastated by a major disaster or large-scale emergency to clean up following the event.

TH-2900.6400-630 Post Disaster Cleanup Information

Programs that provide cleanup tips for people whose homes or businesses have been damaged following a fire, flood, earthquake or other emergency. Included may be things to consider when choosing a restoration company as well as specific suggestions regarding health and safety issues as well as practical advice (e.g., how to deal with soggy carpets, how to clean wooden floors, how to safely dispose of debris) if people choose to tackle the cleanup job themselves.

TH-2900.6450 Post Disaster Family Adoption Programs

TH-2900.6500 Post Disaster Housing Assistance

Programs that provide for the short and long-term housing needs of individuals and families who have lost their place of residence in a major disaster or large-scale emergency by providing them with a mechanism for reporting damage, by arranging for temporary housing while their homes are being repaired or rebuilt, by helping them identify alternative short and/or long-term housing replacement arrangements, by supporting their ability to make structural repairs that will enable them to return to their homes, or by supporting their ability to rebuild. Some forms of post disaster housing assistance are generally also available to individuals who have experienced a localized incident such as a house fire that has made them temporarily homeless.

TH-2900.6500-150 Disaster Specific Home Repair

TH-2900.6500-170 Disaster Specific Permitting Programs

Programs that streamline the process for obtaining building permits and associated construction permits following a major disaster or large-scale emergency to enable people in the affected area to reoccupy their homes or utilize their business property as quickly as possible. Permits may be available at temporary facilities located in or adjacent to the disaster area or through special hotlines established for disaster victims.

TH-2900.6500-200 Disaster Specific Rent Assistance

Programs that offer cash subsidies which enable low-income individuals and families whose homes or apartments have become uninhabitable due to a major disaster or large-scale emergency to obtain alternative housing which may include accommodation in a hotel, motel or rental housing unit. Rent assistance may also be available to individuals who have experienced a localized incident such as a house fire that has made them temporarily homeless.

TH-2900.6500-250 FEMA Trailers

Programs that provide temporary housing in the form of mobile homes or travel trailers that individuals and families whose homes or apartments have become uninhabitable due to a major disaster or large scale emergency involving a Presidential declaration can place on their property and occupy while their primary residence is being repaired or rebuilt.

TH-2900.6500-600 Post Disaster Damage Reporting Hotlines

Programs that compile information regarding viable housing that is available on a rental or donated basis following a major disaster or large-scale emergency and/or which help individuals and families who have lost their homes or apartments during the incident find an affordable or donated replacement.

TH-2900.6500-680 Post Disaster Rebuilding Assistance

Programs that provide financial assistance, building materials and supplies and/or the services of volunteers who have building trade expertise to help individuals and families who have lost their homes in a major disaster or large-scale emergency rebuild.

TH-2900.6800 Post Disaster Legal Counseling Services

Programs staffed by volunteer lawyers who provide counseling and advice at no cost for low-income individuals and families who need assistance with insurance claims, landlord/tenant issues, mortgage/foreclosure issues, home repair contracts and contractors, replacement of wills and other legal documents destroyed in the disaster, drafting powers of attorney, consumer protection matters and other disaster-related legal issues. People who require further assistance are generally referred to a private lawyer who may be able to represent them at no fee or for a reduced fee. Included are programs that operate under the agreement between FEMA and the Young Lawyers Division of the American Bar Association and programs offered by local bar associations or local legal services programs. Legal assistance in the FEMA/Bar Association program is limited to cases that will not produce a fee for the attorney, such as lawsuits in which the lawyer receives a percentage of money obtained through the suit.

TH-2900.8500 Spontaneous Volunteer Management

Programs that seek to maximize the effective utilization of convergent volunteers, i.e., people who spontaneously come forward to offer assistance following a disaster. Responsibilities may include providing information about volunteer opportunities, staging volunteers, providing appropriate tools and directing their activities.
